===== First Aid Measures =====

Handling and Storage Precautions:STORE IN DRY AREA. ELECTRODES EXPOSED TO MOISTURE MAY EXPLODE VIOLENTLY IF USED. DRY MOIST RODS BY BAKING AT 300F FOR TEN HOURS.

Other Precautions:TRAIN WELDER TO KEEP HIS HEAD OUT OF THE FUMES. MONITOR AIR TO ENSURE ACCEPTABLE EXPOSURES. AVOID ELECTRICAL SHOCK BY MAINTAINING DRY WORK AREA.

==== Exposure Controls/Personal Protection =====

Respiratory Protection:FUME RESPIRATOR OR AIR SUPPLIED RESPIRATOR IN CONFINED SPACES OR WHERE VENTILATION DOES NOT KEEP EXPOSURE BELOW TLV.

Ventilation:LOCAL EXHAUST TO KEEP BELOW TLV.

Protective Gloves:WELDER'S GLOVES.

Eye Protection:HELMET OR FACE SHIELD WITH FILTER LENS.

Other Protective Equipment:SUBSTANTIAL DARK CLOTH, ARM PROTECTOR, APRON, HAT AND SHOULDER PROTECTION. AIR SAMPLING TO DETERMINE CORRECTIVE MEASURES

Work Hygienic Practices:WASH HANDS THOROUGHLY BEFORE EATING, SMOKING OR USING SANITARY FACILITIES.
